4. Certificate & Mark sheet confirming passing of Madhyamik or its equivalent from a recognized Board/Council.
5. SC/ST/OBC Certificate, if applicable.
6. Current 'NCL' certificate (for OBC candidates only). NCL certificate should be issued not earlier **than 1<sup>st</sup> April, 2023.**
7. PWD certificate from competent authority.
8. All the documents mentioned above will have to be produced before a Group-A Govt. Officer. Then a certificate in the format prescribed at '**Annexure-A**' will have to be obtained from the officer and sent along with other documents.
  - All Certificate(s) mailed as per 4, 5 and 7 above must be issued on or before the closing date for receipt of application i.e. **25<sup>th</sup> March, 2019.**
  - Candidates are allowed to send above mentioned documents within **14<sup>th</sup> January, 2024** positively.
